2024 Turning Momentum into Action

The newsletter is my time to reflect on the last 3 months, while looking forward to the next 3 months. Today, I find myself thinking, "What will we accomplish in 2024? How will we build on the momentum created last year?" I am struck by a few thoughts.

First, this quarter went fast! I spent 4 years pushing, trying to speed things up. Each day reminding myself that lasting change takes time. It happens in small, incremental, consistent, iterative movements. But WOAH! Can you feel it? The momentum has picked up, the gears are aligning, inertia has joined the movement, and things are moving fast, exponentially faster. I feel a stark change from 4 years ago.

Drug Shortages, the once "hidden healthcare crisis" is hidden no more. Every member of the supply chain is engaged. We no longer have to prove that drug shortages exist or that they harm patients. Every corner of the supply chain and hall of the government accepts this truth. Our combined efforts of advocacy and awareness have been activated into a movement for systemic change! Now our challenge: we must turn this awareness into focused action.

The question I now ask myself each day: how do we focus our efforts to achieve results for ALL patients? Awareness is only the start. Ending drug shortages is the goal. When I testified before congress, I asked for a complete dynamic shift from reactive mitigation practices to proactive ending solutions. Mitigating drug shortages by lowering demand, changing treatments, and rationing patients must become an unthinkable choice. For this shift to happen we must build a patient centric, reliable, redundant, and resilient supply chain.

Last newsletter, I asked if we were ALL IN to fulfill the Change Maker Mission? Now I take that question a step further; are we ALL IN to ensure products are ALL IN leaving no patient behind?

I am encouraged by the legislative engagement in Washington. Now is the time to do everything possible to move robust, systemic, bi-partisan, patient focused, work forward. This is an opportunity we cannot waste. I am measuring solutions by how well the policy answers the below questions:

Does this solution focus on solving the 4 factors that lead to drug shortage? Does this fix economics of this "broken marketplace"? Does this ensure patients receive care without disparity? Does this end drug shortages, mitigate shortages, or does it actually solve some other problem mudding the waters?

Meanwhile, we will continue to activate and support meaningful projects that end drug shortages, ensure patients have access during any scarce event, and bring awareness and advocacy to this crisis. Patients are relying on us to turn this momentum into action. We must not fail them.




PATIENTS WAIT FOR LIFE-SAVING MEDICATIONS

POLICY IN ACTION: SENATE COMMITTEE ON FINANCE WHITE PAPER & A4C APPLAUDS SENATORS

January 25, the Senate Committee on Finance released a white paper that represented the Committee’s preliminary areas of interest and ideas for how policymakers can address the problems contributing to shortages through reforms to the Medicare and Medicaid programs.

“The Committee is interested in options for ensuring that hospitals develop and share drug shortage prevention and mitigation plans across the range of drugs they use in providing care to patients.” Read the full white paper [here](#)

Guide to drug shortages and policy solutions

Center for Health Policy at Brookings

Drug shortages occur when drug supply chains cannot respond quickly enough to changes in demand for supply. Historically, shortages have primarily affected **generic, widely available drugs** because of a combination of economic and technological factors. These drugs are hard to make reliably, but price competition makes it difficult for manufacturers to keep up manufacturing standards. These drugs are primarily made in facilities in the United States and Europe.

Manufacturing quality issues have increasingly been the top reason for shortages, with the percentage of other causes varying from year to year. In the last 10 years, an average of 10% of shortages caused by supply chain issues related to patients. However, shortages due to **regulatory conflicts** are a **growing share** of shortages.

Different strategies are needed to address existing and potential shortages. Addressing shortages requires a mix from all prevention mechanisms that cover the chains of all the steps from a specific shock type. Buffering strategies are the fallback strategy for when the shock could not be sufficiently prevented.

An effective strategy is multipronged, addressing all three elements to varying degrees. What strategy is most effective and least cost-effective [depends on the nature of the shock.](#)
